

Privacy Policy

Termokir Industries (1980) Ltd. (the “**Company**” and/or “**We**”) attaches great importance to maintaining the privacy of its users (as defined below) and makes efforts to protect and properly safeguard their personal information and privacy.

This Privacy Policy (the “**Privacy Policy**”) applies in connection with any use and/or access to the Company’s website available at <https://termokir.co.il> (the “**Website**”). The Website, which is owned by the Company, is an online platform that centralizes information about the range of innovative products and solutions that the Company develops in the field of construction, including technical specifications, professional application instructions, access to a Digital Advisor that helps tailor solutions to specific project needs, etc. (the “**Services**”).

As part of accessing the content available on the Website and using the Services offered on it, and depending on the type of use, the Company may collect personal information about Website visitors (collectively referred to as “**User(s)**” and/or “**You**”). The purpose of the Privacy Policy is to provide information to users about the information collected, the purposes of the collection, the use that will be made of the personal information, as well as the rights of the User in relation to its personal information.

The Company may (but is not obliged) to retain the personal information that will be collected in connection with the use of the Services about the Users in the Company’s databases, in accordance with the provisions of the Privacy Policy and in accordance with the provisions of applicable law.

Termokir Industries (1980) Ltd. Pvt. Co. 510890619 is the “Controlling owner of the Database” in relation to personal information collected in the context of the use of the Services, as defined under the Privacy Protection Act 5741-1981 (“Privacy Protection Act”). 1. User Consent to the Terms of the Privacy Policy

By accessing the Website as well as using the Services, you agree to the collection and use of personal information by the Company in accordance with the Privacy Policy. If you do not agree to the Privacy Policy, in whole or in part, or if you are not legally qualified to give such consent, you must refrain from using the Services.

It is hereby clarified that you do not have any legal obligation to provide the Company with personal information. The provision of personal information by you depends on your free will and consent. However, the provision of certain

personal information may be necessary in order to fulfill the purpose for which it is collected, including for the receipt of certain services, as detailed in Section 2 of this Privacy Policy.

Without derogating from the above, you declare that you are aware that without providing the required information in the mandatory fields on the Website, which may vary depending on the type of service requested, you will not be able to receive the response and/or service requested. For example, if you wish to contact us to receive answers to certain questions, we will not be able to provide you with an answer without you providing us with your contact information. If you provide us with information about another person, you declare that you have all the necessary and valid consents for the purpose of providing such information.

2. Information Collected When Using the Services, the Purpose of Collecting It and Its Use By the Company

2.1. When accessing and/or using the Services, the Company may collect and use different information, depending on the type of use:

- **Personal Information** — Means information relating to a person identified or identifiable through reasonable effort, directly or indirectly. For example, information that can be used to contact you, including, your name, email address, telephone number, etc.
- **Information that Does Not Identify the User** — Means information that in itself is not linked to a particular User, device or browser, and includes primarily aggregate usage information of the User (which is not identified as mentioned above) and/or technical information transmitted from the device used (such as device type, browser type, operating system, language), as well as statistical information related to the scope of use of the Website including date and time of use, duration of use, Frequency of use, observed pages and the like. The Company may make unlimited use of this information, and it is primarily used for the purpose of operating the Website, analyzing trends, improving the services and improving the User Experience.

2.2. The Company may collect the information above and below when such information is provided directly by the user and/or automatically through the use of technological tools and information-aggregating technologies such as “Cookies” and/or other technological tools and/or on behalf of third parties.

2.3. The Company may collect the following types of Personal Information about the User, for the purposes set out below:

3. Use of Technological Tools and Cookies

- 3.1. When accessing and using the Website, the Company may use various technological tools that automatically collect information, such as "Cookies", for various purposes, including the proper operation of the Website and its security, to improve the browsing experience of the Website and the use of the Services, to collect statistics about the use of the Website, retaining User preferences, etc. Cookies are small text files that are stored by the Company's server in the memory of the User's computer or device or browser. These tools may include the automatic collection of information, including personal information, such as online identifiers and device and usage data (as defined under Section 2 of the Privacy Policy).
- 3.2. The Company may make use of such technological tools on behalf of third parties, including technological tools used for advertising and online marketing. It should be noted that certain third parties who have used technological tools on their behalf for online advertising and marketing (for example on behalf of Google), may collect and use certain data independently, combining it with other information collected from your online activities on other websites, for the purpose of displaying personalized advertisements, as well as providing aggregate analysis of the performance of an online advertising campaign. It is clarified that these third parties collect and use the

data subject to their privacy policies and therefore we recommend that you review the privacy policies of these third parties as set out below.

3.4. Opting Out of Data Collection via Cookies:

The settings of each browser include the possibility to refuse to accept Cookies and delete existing Cookies. If you choose to block or delete Cookies, some Services on the Website may not be accessible and/or your experience of using the Website may be limited.

4. Transfer of Information and Sharing of Information With Third Parties

The Company will not share with third parties the personal information collected about you in the course of using the Website, except as set out below:

- 4.1. Suppliers and Service Providers** – The Company may transfer the information to suppliers and/or service providers and/or subcontractors, in Israel and/or abroad, who provide services for it, including marketing services, storage, servers, customer service, support service, and the like.
- 4.2. Online Advertising and Analytics Providers** – The Company may share information with third parties through the use of “Cookies” and technological tools for online advertising (as detailed under Section 0 of the Privacy Policy).
- 4.3. Compliance With the Legal Provisions and/or the Administration of Legal Proceedings** — The Company may share information for the purpose of clarifying claims and managing disputes and/or legal proceedings that will be conducted between the User and/or those on its behalf and the Company and/or on his behalf including third parties related to its business and/or in any case in which the Company believes, at the Company’s sole discretion, that the provision of the information is necessary in order to prevent material damage to the Company and/or the Users; and/or to other third parties.
- 4.4. Enforcement of Terms of Use, Security and Fraud Prevention** — The Company may share information with relevant third parties in the event that it believes that any of the actions of the Users of the Website violate the Terms of Use of the Website or have been done in violation of any law and/or in the event that the Company is obliged to do so by a judicial order and/or order of any competent authority (Tax Authority, Israel Police, etc.) and/or under any law.
- 4.5. Merger, Acquisition or Organizational Change** — Subject to the provisions of the law, the Company may transfer all information about users gained from it in the course of the transfer or conversion of its business (all or part of it) and/or restructuring, merger, joint ventures and other transactions in connection with its business (including in the framework of negotiating such transactions) and for the continued provision of services by the third party.

5. Information Security and Transfer Outside of Israel

The Company implements industry-standard security measures to maintain the confidentiality of Users' Personal Information, protect their privacy, and reduce the risk of unauthorized access to or use of such information. However, complete protection cannot be guaranteed and there may be security breaches and intrusions into systems that are beyond the reasonable control of the Company. Subject to the Company's obligations under law, the Company does not undertake that the Website and/or the systems used to store the Personal Information will be completely immune from unauthorized access to the information stored therein.

In Addition, the Company may process or store information both in Israel and outside of Israel. The User hereby acknowledges that by using the Website, its information may be transferred, stored and processed on the Company's servers and/or by suppliers outside the State of Israel. The transfer of information shall be made in accordance with the provisions of the applicable law.

6. Duration of Information Retention

We will retain your personal information for the period of time necessary to fulfill the purpose for which it was collected, and in particular to provide you with the services. Your personal information may be retained for a longer period, as and when we deem

necessary, in order to comply with our legal obligations, resolve disputes and enforce our agreements.

7. User Rights Regarding Personal Information

The Company respects your privacy and control over your Personal Information. Under the Privacy Protection Act, your rights regarding your Personal Information contained in the Company's database are as follows:

- ۸. You may request to review the Personal Information about you held by the Company.
- ۹. You may correct and/or delete the Personal Information about you if you have found that the Personal Information is incorrect and/or out of date.
- ۱۰. If you do not wish to receive marketing communications from the Company, you may, at any time, request your removal from the mailing list using the "Remove" option in the marketing message sent to you.
- ۱۱. In addition, if the Personal Information held by the Company is used for the purpose of direct communication with the User based on their affiliation with a specific population group (known as "Direct Mail"), in accordance with the provisions of the Israeli Privacy Protection Law, you are entitled to request in writing the deletion of such Personal Information from the database used for Direct Mail.

Please note that, after requesting removal from the mailing list mentioned above, you will not be sent marketing messages, however, the Company may continue to send you inquiries required for the service (for example, responding to your enquiry). It is also clarified that information necessary for the Company to conduct its business, including documentation of actions performed in connection with Services provided, will be retained by the Company in accordance with law, but will no longer be used for Direct mail purposes and/or for any other purpose except for complying with the provisions of the law and/or protecting the Company's rights under law.

When requesting to correct and/or review and/or delete personal information as mentioned above, and in order to protect users' privacy, the company may request certain details for identification purposes prior to responding and/or fulfilling the request.

8. Changes to the Privacy Policy

We reserve the right to change this Privacy Policy from time to time and as necessary at the sole discretion of the Company and subject to legal provisions, without the need for notice, prior and/or retroactive notice. Any changes that may be made will take effect immediately upon the posting of the updated Privacy Policy on the Website. The date of the update will be indicated under the "Last Updated" heading at the top of the Privacy Policy. Therefore, it is recommended that you review the Privacy Policy from time to time. Your continued use of the Services after such changes are made will indicate your acceptance of these changes and the updated Privacy Policy. Unless you agree to the changes mentioned above, all or some of them, please refrain from continuing to use the Services.
